Yearly membership dues are \$100.00 per each prospective member. Full membership dues are to be paid at the time of application. Points will begin to accumulate when membership dues are paid. There are no payment plans available.

1. Each contestant is required to sell \$100.00 worth of raffle tickets. The winner of the raffle will be drawn and announced at the TJRA Finals Awards Ceremony. To compete at

the Finals, all contestants must pay the \$100.00 of raffle ticket money. ALL RAFFLE TICKET MONEY WILL BE DUE SUNDAY, JUNE 15, 2025, BY THE END OF THE RODEO. If your raffle money is not turned in at or before this time the contestant will drop all points accumulated. The contestant may begin accumulating points after the \$100.00 raffle ticket money is turned in.

2. All Finals contestants MUST bring an auction item of \$25.00 value for the silent auction to be held at the TJRA Finals.
3. To qualify for the TJRA Finals, a competitor must compete in at least 10 of the 18 rodeos and be in the top 15 placings. ALL FEES AND FINES MUST BE PAID TO BE ABLE TO ENTER THE FINALS.

This provision shall be binding upon each TJRA member, his/her spouse, legal representative, heirs, successors, and assigns".
